

Annexure – 1

The Research Advisory Committee shall have the following powers and functions namely:

- (a) to exercise general supervision over the research work conducted within the University;
- (b) to consider all matters related to research on its own initiative or when referred by various Colleges/Institutions/School of the University;
- (c) to promote Inter- Faculty and Inter-Departmental research in the University;
- (d) to frame and implement guidelines for conducting and monitoring research including, but not limited to the following:
 - (i) Ethical conduct of laboratory, animal and clinical research;
 - (ii) Procedure for submission and funding of research proposals;
 - (iii) Reporting progress of research projects;
 - (iv) Dissemination of research findings through publications and presentations;
 - (v) Submission of research budget to the Finance Committee;
 - (vi) Monitoring of research expenditures;
 - (vii) Documentation of all research activities of the University.
- (e) to undertake annual review of the research activities of Departments, Faculties, Academic Unit and Campuses of the University; and
- (f) To facilitate collaborative and multi-disciplinary research in conjunction with National, International, Governmental & Non-Governmental Institutions, Universities, Organizations and Agencies;
