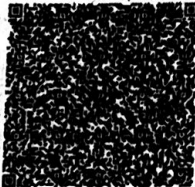

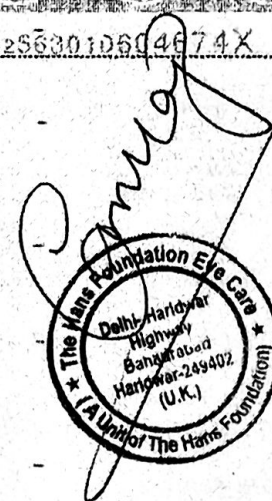

1. Preamble

This Memorandum of Understanding (MoU) is made on this 3rd day of December 2025, between:

- i. Shri Guru Ram Rai Institute of Medical & Health Sciences (hereinafter referred to as "SGRRIM&HS"), Shri Guru Ram Rai University, Dehradun, Uttarakhand, and
- ii. The Hans Foundation Eye Care, Bahadarabad, Haridwar - a charitable hospital managed by The Hans Foundation (hereinafter referred to as "THFEC").

SGRRIM&HS and THFEC are hereinafter individually referred to as a "Party" and collectively as the "Parties".

2. Purpose

The purpose of this MoU is to establish a formal collaboration between the Parties to extend the services of the Institutional Ethics Committee (IEC) of SGRRIM&HS for ethical oversight of clinical research, postgraduate dissertation work, and academic activities undertaken by DNB trainees of THFEC, as required under the NBE accreditation process.

3. Objective

The collaboration aims to:

- *Ensure all research and clinical activities involving human participants at THFEC comply with approved ethical standards.*
- *Facilitate review and approval of research proposals from THFEC by the SGRRIM&HS IEC.*
- *Promote academic cooperation, guidance, and knowledge exchange between the institutions.*

4. Scope of Collaboration

- The SGRRIM&HS IEC shall review and monitor all research proposals, clinical studies, and dissertations from THFEC as per national ethical guidelines.
- There will be minimum 1 guide from THFEC and 2 co-guides from both the institutes. SGRRIM&HS may also provide a guide to THFEC if requires on mutually discussed terms.
- SGRRIM&HS may levy a nominal fee per project for IEC review, mutually decided.
- The sharing, publication and presentation of the data from both the institutes must be in approval of the IEC.
- Both Parties agree to maintain confidentiality of data and adhere to all applicable laws and ethical standards.
- The Parties may explore additional collaborations in education, research, and training as mutually agreed.
- Sri Guru Ram Rai Institute of Medical and Health Sciences (SGRRIM&HS) shall impose a Processing Fee of INR 2,500 (Rupees Two Thousand Five Hundred only) and a Thesis Support Fee of INR 27,500 (Rupees Twenty-Seven Thousand Five Hundred only) per project for review by the Institutional Ethics Committee (IEC). The updated fee structure shall be applicable in accordance with notifications issued by SGRRIM&HS from time to time.

5. Tenure and Renewal

This MoU shall remain valid for three (3) years from the date of signing and may be renewed thereafter with mutual consent in writing.

6. Termination

- Either Party may terminate this MoU by giving 30 days' written notice to the other Party.
- Termination shall not affect obligations already undertaken prior to the date of termination.

7. Confidentiality

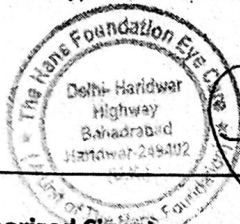
Both Parties shall treat all research data, participant information, and institutional documents as confidential and use them solely for purposes outlined in this MoU.

8. Governing Law

This MoU shall be governed by the laws of India and subject to the jurisdiction of the courts at Dehradun, Uttarakhand.

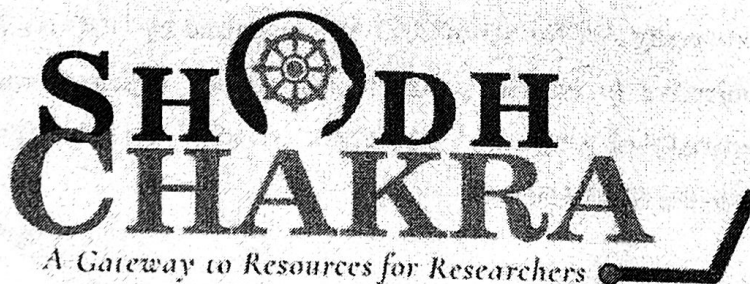

MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MoU) is entered on 10th October, 2025 by and between:-

- (i) Information and Library Network (herein referred to as "INFLIBNET"), An IUC of UGC, Govt of India is located at Gandhinagar, Gujarat- 382007.
- (ii) Shri Guru Ram Rai University (herereferred to as "University") Patel Nagar Dehradun, Uttarakhand, 248001 address, city, state, pin

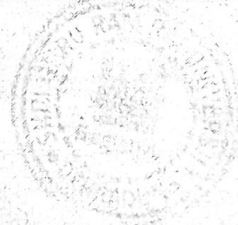
University and INFLIBNET are referred to individually as "**Party**" and collectively as "**Parties**". Both parties have reached the following broad areas of cooperation & collaboration intent.

WHEREAS INFLIBNET Centre, an Inter-university Centre of the University Grants Commission of India under Ministry of Education, Govt. of India undertakes activities and services that include automation of academic libraries and information centers, providing access to subscribed and open access e-resources, e-content, ranking of institutions, development of web applications to facilitate scholarly communication and maintenance of bibliographic and non-bibliographic database, etc.

AND WHEREAS University, is a University established by Govt. of Uttarakhand vide Shri Guru Ram Rai University Act No. 03 of 2017 & Recognized by UGC u/s 2(f) of UGC Act 1956 with an objective to conduct research and provide higher education in various disciplines as approved time to time by the academic council of the university. University has agreed to take part in the ShodhChakra.

Shodh-Chakra

Shodh-Chakra is an initiative of Information and Library Network (INFLIBNET) Centre under the guidance of University Grants Commission (UGC) to help the academic community during their research life cycle. Shodh-Chakra provides a unique space to the researcher, guide/supervisor and university to manage the research lifecycle of a research scholar. The portal is integrated with millions of resources (including lakhs of full-text theses) along with the helping tools for the researcher which are required during the research work. It will provide the research trends of the country.

Purpose of MoU

This Memorandum of Understanding (MoU) defines responsibilities, liabilities and commitments of the universities / institutions involved to ensure proper implementation of the ShodhChakra for its stakeholders.

Roles and Responsibilities

1. INFORMATION AND LIBRARY NETWORK CENTRE (INFLIBNET CENTRE)

The broader role and responsibility of INFLIBNET are as follows:


- 1.1 Shall provide access to Shodh-Chakra platform;
- 1.2 Shall integrate new features / resources into platform from time to time;
- 1.3 Shall provide help manual / video tutorials for its stakeholders;
- 1.4 Shall provide one day orientation / training programme for the University's stakeholders (researchers / guides / other concern officials) on mutual consent;
- 1.5 Shall ensure the data security;
- 1.6 Shall customise platform for university on mutual consent.

2. University / Institution

The broader role and responsibility of University / Institute are as follows: -

- 2.1 Shall register into Shodh-Chakra platform;
- 2.2 Shall create profile of university including school/department details;
- 2.3 Shall verify / approve the researchers' / guide details;
- 2.4 Shall nominate nodal officer for its implementation;
- 2.5 Shall access the features of the ShodhChakra platform;
- 2.6 Shall encourage and ensure that every Research Scholar / Research Supervisor participate in said platform;
- 2.7 Shall not hold INFLIBNET Centre responsible for any errors and omissions contained in researchers and supervisors' data;
- 2.8 Shall follow UGC respective guidelines (time to time);
- 2.9 Shall arrange capacity building programmes for stakeholders, if required.

3. RELATIONSHIP

This MoU between the INFLIBNET Centre and **University** is on principle of Service Provider (INFLIBNET Centre) basis and nothing in this MoU shall constitute or deemed to constitute a partnership between any of the Parties hereto and none of them shall have any authority to bind the others in any way.

4. TERMINATION


