

2. AND WHEREAS, the recognition was granted by NRC to Shri Guru Ram Rai (PG) College, Village-Dehra Khas Pathri Bagh, Near Railway Station, Post Arhat Bazar, Dist.-Dehradun, State-Uttarakhand for B.Ed. Course vide order F. NRC/NCTE/F-7/UR-86/2009/12458-12464 dated 18.11.2009 with an annual intake of 100 students from the academic session 200-2010.

3. AND WHEREAS, the institution Shri Guru Ram Rai (PG) College, Village-Dehra Khas Pathri Bagh, Near Railway Station, Post Arhat Bazar, Dist.-Dehradun, State-Uttarakhand has by affidavit consented to come under New Regulations and sought for one basic units in B.Ed., which require additional facilities.

4. AND WHEREAS, it has been decided to permit the institution to have one basic unit of 50 student subject to the institution fulfilling following conditions namely.

- (i) The institution shall create additional facilities that include (a) additional built-up-area, (b) additional infrastructure, (c) additional funds, (d) adhere to staff norms as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
- (ii) The application-Institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan (BP) in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting Team at the time of inspection.
- (iii) The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these condition by 20 February, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
- (iv) In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted alongwith the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institution shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. Now therefore, in the light of the above, the Northern Regional Committee, NCTE hereby issues the revised Recognition Order to Shri Guru Ram Rai (PG) College, Village-Dehra Khas Pathri Bagh, Near Railway Station, Post Arhat Bazar, Dist.-Dehradun, State-Uttarakhand for conducting B.Ed. programme of two years duration with an annual intake of 50 for one basic units of 50 student from the academic session 2015-2016 subject to fulfillment of the conditions mentioned herein before 31.10.2015.

The affiliating body (University/State Govt.) shall also be required to verify the authenticity of the land & building documents as well as







ORDER

WHEREAS Shri Guru Ram Rai (PG) College, Village - Dehra Khas Pathri Bagh, Near Railway Station, Post Arhat Bazar, Dist. Dehradun, Uttarakhand had submitted an application to the Northern Regional Committee of NCTE, Jaipur for grant of recognition / permission for starting M.Ed. course one year duration on 10.10.2007.

2. AND WHEREAS Northern Regional Committee in its 137th meeting held on 26th February to 1st March 2009 after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution decided to ask the letter of University regarding the appointment of the expert on the selection committee and Minutes of the selection committee. Accordingly a letter was issued to the institution on 17.3.2009.

3. AND WHEREAS the applicant institution has not submitted reply. The matter was placed in NRC in its 142nd meeting held on 14-16th June 2009. The original file of the institution, alongwith all other related documents, affidavits, Act of NCTE, 1993, Regulations and guidelines of NCTE published from time to time, etc were considered and committee had decided to refuse recognition for M.Ed. course. Accordingly, Refusal order has been issued on 4.8.2009.

4. AND WHEREAS the applicant institution has preferred an appeal on 18.08.2009 against the withdrawal order of NRC dated 18.08.2009 to the appellate authority. The appeal of the institutions was accepted and NRC's order dated 04.08.2009 was reversed with direction to NRC issue recognition order within 15 days vide order dated 08.10.2009.

5. AND THEREFORE, in exercise of the powers vested under Section 15(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition/permission to Shri Guru Ram Rai (PG) College, Village - Dehra Khas Pathri Bagh, Near Railway Station, Post Arhat Bazar, Dist. Dehradun, Uttarakhand for conducting M.Ed. Course of one year duration with an annual intake of 25 (twenty five only) students from the academic session 2009-2010 under clause 7(11) of NCTE Regulations, 2007 notified on 10.12.2007 subject to fulfillment of the following conditions as per the clarification from NCTE HQtrs letter No. file No. 48-3(1)/2008/NCTE/(N&S) dated 01.10.2009.

- I. The admissions of students shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of the students shall be completed well before the cut off date prescribed by the examining body for the academic session 2009-2010, failing which the recognition will be effective from the academic session 2010-2011 only.
- II. Formal orders for recognition / permission will operate for 2009-2010 only if the requirement of 180 teaching days in the session is fulfilled as per calendar of the University/Affiliating body.

7. The institution shall, within one month of the receipt of recognition order, convert the endowment fund and Reserve fund account into a joint account to be operated along with an officer of the Northern Regional Committee.

8. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

9. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulation, 2007 notified on 10.12.2007.

10. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.
11. The Institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.
12. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act.
13. The Institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-
 - (i) Copy of the Application Form
 - (ii) Land and Building Particulars
 - (iii) Staff Profile
 - (iv) Recognition letter
 - (v) Information for having fulfilled the norms & standard and other required conditions.
14. In case if the land is in the name of the Society, you must transfer the land within six months in the name of institution failing which action shall be initiated to withdraw the recognition. It shall be essential on part of the institution concerned to get the needful done in this regard and intimate the respective Regional Committee alongwith the new land documents within stipulated time.


