The Chairperson, Dr. Malvika Kandpal initiated the discussion by providing an overview of the current M.Ed. syllabus.

- Prof. Anand Kumar greeted to BOS members and all faculty members for BOS meeting, He enlisted meeting agenda to all members and appealed to all committee members for open discussion and suggestions on curriculum contents of Master of Education.
- Prof. Anand Kumar has taken the review of minutes of BOS meeting which was held on 21 st July 2021. Minutes were confirmed and approved by BOS.
- Prof. Anand Kumar has given the presentation on the structure and course contents prepared for syllabus of Master of Education (M.Ed.)- Two year programme.

- Review of Current M.Ed Two year Syllabus
- · Identification of Areas for Improvement
- Discussion on Curriculum Changes
- · Areas for improvement were identified, including:
 - Integration of contemporary educational theories and practices.
 - Enhancement of research components within the curriculum.
 - Ensuring alignment with current educational standards and policies.
 - Incorporation of practical experiences and fieldwork opportunities.

A thorough discussion on potential curriculum changes took place, resulting in the following decisions:

Action Items

During meeting the following suggestions were highlighted

 In eligibility criterion B.Com. B.Ed. should be added along with B.A. B.Ed. and B.Sc. B.Ed.

BOS discussed the content of various courses and recommended to keep COs limited to 4 maximum 8, and for courses MED106, MED111, MED118 and MED121 it should be limited to 2, while in case of MED119, it should be 3 only.

- POs and PSOs were also discussed by the BOS and recommended that POs should be limited to 8 maximum 10 and PSOs should be limited to 6 only.
- In course code MED101, books of some Indian authors should be included under suggested readings.
- In course code MED102, under CO 102.4, NEP2020 should be added with National Policy on Education 1968, 1986 and 1992 and NEP 2020 should be included under Unit-II (4).
- In course code MED107, under CO 107.6, Idealism and Realism should be added.
- In course code MED107, under Unit-IV (7), some western philosophers like Plato, Rosseau, Jhon Devi and Charls Sanders Peirce should be added.
- In course code MED116, in Unit-I(2) year 1964-66 should be added against Kothari Commission.
- Nomenclature of course code MED111 and MED118 should be written as "Preparation and Presentation of Synopsis" and "Collection and Analysis of Data" respectively.
- Inclusion of MooCs courses in Semester II & III were appreciated by the subject experts.
- BOS also discussed and recommended the introduction of 08 weeks internship of total 08 credits, in two phases. First 04 weeks Internship (weightage 04 credits), in any teacher education institution, should be in second semester and second 04 weeks internship (weightage 04 credits), in any secondary or senior secondary school, in third semester should be introduced.

Faculty members gathered feedback from students regarding their experiences with the current syllabus.

Total 16% (approx.) of syllabus has been revised and revised structure and syllabus for Master of Education (M.Ed.) programme is approved by the BOS.
