
Student Feedback Analysis Report 2018-19:

The Feedback Analysis Committee of the school designs and collects feedback from its stakeholders to monitor and evaluate its performance quality on curriculum and curriculum related issues. The feedback forms were collected from students on several issues. After analysing the feedback received from the teachers the following conclusions were drawn in response to ECS pattern of curriculum and course content was, 12.7% suggested as excellent, mentioned as very good, 21.27% suggested as good and 14.89 % considered as average. For methods of delivery of curriculum, 10% suggested as excellent, 53% mentioned as very good, 21% suggested as good and 14% considered as average. In case of rating in Credit allocation to the coverage of course curriculum, 17% suggested as excellent, 69% mentioned as suggested as good and 14 % considered as average. For rating in Course Curriculum in skill development, 21% suggested as excellent, 59% mentioned as very good, suggested as good and 20 % considered as average. In case of rating fairness in the assessment process, 25% suggested as excellent, 51% mentioned as very good, 16% suggested as good and 8 % considered as average. For rating academic ambience of the university for effective learning, 17% suggested as excellent, 50% mentioned as very good, 25% suggested as good and 7 % considered as average. In the direction of rating for course content coverage by teachers, 10% suggested as excellent, 63% mentioned as very good, 21% suggested as good and 14 % considered as average. For availability of study materials and books in library, 17% suggested as excellent, 46% mentioned as very good, 30% suggested as good and 7 % considered as average. For applicability of curriculum to real life situations, 19% suggested as mentioned as very good, 25% suggested as good and 10 % considered as excellent, 44% average. Following suggestions received are as an addition of textbooks as per syllabus, balanced between theory and practical classes are needed. Enhancement of job oriented courses. The feedback report was forwarded to IQAC for necessary action and thereafter the analysis is shared with all constituent colleges, heads and they are instructed to take necessary measures and actions as to comply with the issues raised by the students.

After analyzing the feedback received from the Students the following conclusions were drawn:




- 1. The pattern of curriculum is contemporary and need based, 68.75% faculties strongly agreed and 31.25% agreed.







Count of Methods of delivery of curriculum





In response to rate, Sufficient reading material and digital resources are available in the library agree response at 40 % followed by agree response 35.29% showing neutral rating at 30%.



- 4. Regarding weightage given to theory and practical, 8 % strongly agreed, 73 % agreed while 19% were Neutral.
- 5. In respect of Board of studies taking care to ensure the currency and relevance of the programme offering 8% are faculties strongly agreed, 67% agreed with fact while 26% were neutral.
- 6. In concern with freedom to contribute ideas on curriculum design and development, 8% faculties strongly agreed, 59 % agreed and 33% neutral.
- 7. The system followed by the University for the design and development of curriculum is effective, 8 % faculties are strongly agreed, 68% are agreed and 24% neutral.
- 8. Sufficient reading materials and digital resources are available in the library. None strongly agreed, 76 % agreed, 17% are neutral whereas 8% disagree with fact.
- 9. Sustainability of evaluation system 42% agreed, 46% were neutral and 12% disagreed.






