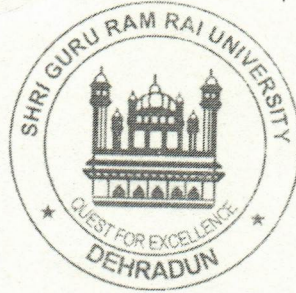

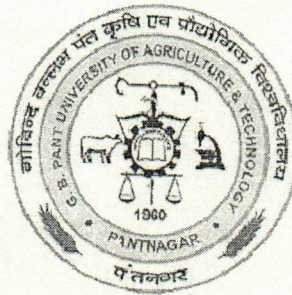

## MEMORANDUM OF UNDERSTANDING

IT'S BETWEEN THE KRISHI VIGYAN KENDRA, DHAKRANI, G.B.PANT UNIVERSITY OF AGRICULTURE AND TECHNOLOGY, PANTNAGAR AND SGRR UNIVERSITY, PATELNAGAR, DEHRADUN FOR SCIENTIFIC AND TECHNICAL COOPERATION IN THE **SEED HUB OF PULSES PROJECT** (PULSE SEED PRODUCTION PROGRAM).

1. This MoU made on 04<sup>th</sup> October, 2018 between the K. V. K., Dhakrani under G.B.P.U.A.T., Pantnagar established in 2005, as the First Party and the Shri Guru Ram Rai University, Patel Nagar, Dehradun established under University Act No. 03 of 2017 situated in the State of Uttarakhand hereinafter called the Second Party.
2. As per the MoU, the KVK (first party), GB Pant University, Pantnagar shall provide scientific and technical guidance in **Seed Hub of Pulses Seed Production Program**. The items of assistance include the following:
  - (i) Pulse crop offered for Seed Production Program is urd bean (Var.- PU 31) in *kharif* 2018 and lentil (Var.- PL-8) in *rabi* 2018.
  - (ii) The Krishi Vigyan Kendra (KVK), Dhakrani, G.B. Pant University of Agriculture and Technology will provide breeder seed on payment basis for seed production.
  - (iii) Monitoring & Inspection by scientists of G.B. Pant University as per the need of crop and its certification through appropriate agency.
  - (iv) After harvesting of urd bean and lentil produce will be buy back by the KVK, G.B. Pant University with MSP (Minimum support Price) in addition to 10% for promotion of such program.
  - (v) University will not charge any consultation fee for providing technical guidance and any support thereof.
3. For scientific and technical cooperation in the effective implementation of the programme and for obtaining assistance as stated herein above, the second party shall make available the following:
  - (i) In the first phase at least Ten (10) hectares of good quality cultivable land at its university farm and seed production will be done by SGRR University on its farms thereof and other required field/laboratory facilities for imparting instructions through work-experience/learning by doing.





- (ii) All required inputs and appropriate facilities for execution of programme in farm.
- (iii) Purchase of breeder seed of urd bean (Var. PU31), lentil (var. PL-8) and necessary pesticides.
- (iv) Required labours, farm implements, building/warehouse presently available with the University will be used as per the need.




