MEMORANDUM OF UNDERSTANDING (MOU)

This memorandum of understanding (MOU) is for cooperation in health education, research, and service fields for developing a collaborative arrangement whereby the Institutions may participate in collaborative teaching, training, research, and other agreed activities to enhance the relationship between the two Institutions further.

This MOU is entered between:

Shri Guru Ram Rai University, Dehradun, established by Govt. of Uttarakhand, vide Shri Guru Ram Rai University Act No. 03 of 2017 Act No. 03 of July 2017, having its registered office at Pathribagh, Dehradun (Uttarakhand), 248001, India, represented herein by its authorised signatory, Prof. (Dr.). Deepak Sahni, Registrar (hereinafter referred to as "SGRR University", which expression shall where the context admits, mean and include each of its trustees their respective heirs, executives, successors and assigns);

And

Indian Institute of Technology. Roorkee, Uttarakhand -247667 India (hereinafter referred to as "IIT Roorkee) is among the foremost Institutes of National Importance in higher technological education in engineering, basic and applied research. Since its establishment, the Institute has played a vital role in providing the technical manpower and know-how to the country and in pursuit of research, acting through Dean, Sponsored Research and Industrial Consultancy, which expression shall, unless repugnant to the context, include its successor, administrators, assigns or legal representatives.

Both institutions state that they:

Recognise the value of academic interchange and lively engagement with the national and international scholarly community by members of research institutions.

Discern the significance and importance of collaboration in pursuing national and international cooperation and awareness of each institute's interest in and need for establishing and sustaining such cooperative ties.

Confirm the significance of furthering knowledge and the creative role of national and international scholarly communication and collaboration in the development and dissemination of learning and research.

Hence, in the spirit of promoting exchanges between them in all pertinent areas of health education, research, and service, both institutions agree as follows:

A. General Objectives:

- i. To exchange mutually beneficial information, articles, reports, and teaching materials to support each institution's educational programs in the field of Professional Competencies (particularly the areas of Communication Skills, Ethics, Professionalism, Self-Care, and Self Awareness).
- ii. To strengthen and encourage communication and collaboration in education and research between members of the two institutions, particularly with respect to the Professional Competencies program.
- iii. To stimulate contact between investigators in health science from the two institutions.
- iv. To develop academic projects such as collaborative research, teaching, technical cooperation, evaluation, and publication. The human and technical resources which will contribute to designing and operating the program shall be specified by each institution. Also, the mechanism and action to evaluate, supervise and utilise the products of the programs above shall be jointly established.
- v. To promote bilateral cooperation in scientific research and education in different faculties involving a Teaching and exchange of scientific researchers
 - a. Teaching and exchange of scientific researchers.
 - b. Organizing lectures, seminars, and scientific meetings
 - c. Development of projects of common interest
 - d. Visits of faculty and students for the mutual benefit of both institutions.
 - e. Co-operation in the conduct of research (except finances).

B. Scholar Exchange and Education Collaboration

- i. To develop learning opportunities through courses, seminars, workshops, and other means from both institutions to pursue activities related to scholars' academic programs, particularly concerning developing a Professional Competencies curriculum adapted for use at the respective institution.
- ii. To facilitate visits by medical students between institutions and vice versa who will assist with the rollout of the Professional Competencies curriculum and participate in clinical electives. In addition, to facilitate visits by students from other related disciplines (such as Global Health or Nursing), as required for the implementation and evaluation of the Professional Competencies program

- iii. To facilitate the exchange of health science faculty members and visiting scholars dedicated to participating in teaching and research
- iv. In all cases, the exchange of faculty members and visiting scholars will occur within the regulation of each institution and will take place individually.

C. Legal Conditions

- i. This MOU is a statement of intent and in no way intended to create a legal or binding obligation on either Institution and serves only as a record of the institution's current intention to enhance the relationship of the Institution going forward. This MOU does not create legally enforceable rights claim, interest, duty, or obligation in favour of either of the party as against the other party.
- ii. All cooperation is on a self-finance basis, and none of the institutions is obliged to support each other financially for this MOU.
- iii. The Institutions agree to designate the following person as the administrative focal point for any administrative aspects of this MOU.

- iv. All student and faculty exchanges will be approved at the departmental and institute level through the appropriate mechanisms per defined procedures and regulations prevailing at the corresponding institute.
- v. For coordinating visits, correspondence, and exchange, visitors will communicate with a counterpart in the institutions where cooperative research and teaching activities are managed.
- vi. All risk procedures within the policy structure defined by concerned institutions will be carried out and reported on before any exchanges occur.
- vii. All intellectual property from joint R&D will be as per the IPR policy of IIT Roorkee. A separate agreement will be made for this on a case-to-case basis.
- viii. Before any particular cooperative project or program is initiated, all financial detail shall be negotiated, especially allocation to effect by administration authorities. Notwithstanding anything contained in this MOU, each institution will remain responsible for its own initiative at the level of finance.

- ix. Cooperative projects requiring financial support shall not be initiated in the expectation of support by either institution before such funding has been explicitly agreed to and committed by written consent, and a further agreement would be required.
- Χ. This MOU shall come into effect for a period of ten (10) years from the date of signature of both parties and shall be renewed with their mutual consent and signature. It may be extended by the written agreement of both partners.
- xi. In case of any dispute or difference relating to this MOU, both parties agree to resolve the same through mediation before going to arbitration or litigation.
- Either party may terminate this MOU with six months' advance written notice to xii. the other party. Competent courts in Uttarakhand shall have exclusive jurisdiction.
- xii. Both parties of this MOU agree to act in good faith and in a spirit of mutual understanding and accommodation to facilitate achieving goals set under this MOU.
- xiii. SGRRIM&HS Dehradun would give preference to IIT Roorkee faculty, students & staff for providing medical facilities for patient care.
