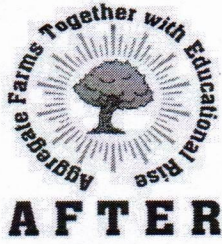

Aggregate Farm Together with Educational Rise (AFTER) Society R/o- 67 Canal Chowk Road, kaulagarh Dehradun, Uttarakhand – 248195, Represented by Secretary, AFTER Society which expression shall unless repugnant to the subject or context mean and include its successors and assignees of the **SECOND PART**.

Hereinafter referred to as 'Second Party (which expression unless repugnant the context or meaning there of shall mean and include its successors) of this part.

The purpose of MOU is to bridge the gap between Farmers & Academia; MOU will promote collaborative training & research with esteemed concern. In this context, both the parties will mutually work on farmers & students trainings, research at farmer's field and providing platform for practical experience to students in core research field of Agriculture & Allied Sciences.

This Agreement will be amended by mutual agreement of the Parties. Such amendments shall not be binding unless they are in writing and signed by personnel authorized to bind each of the Parties.

Parties are desirous to establish academic linkages and contacts through a MOU with the following objectives:

This Memorandum may be terminated by either party, after the completion of any specific activity / activities in the process with mutual consent.

This Memorandum will have the Provision that after the termination / completion of tenure which it intends, the II party will have no right to use the property of **SGRR University**, in any form thereafter.

This Memorandum encompass certain reservations that the use of **SGRR University**, / Brand Name shall not be done without approval of the University authorities. This Memorandum encompass certain reservations that the of **SGRR University**, / Brand Name / Logo termination / completion of tenure will lead to forfeited the use of **SGRR University**, / Brand Name / Logo and vice-versa thereafter for whatsoever reason.

Matters not provided in

If any doubt arises as to the interpretation of the provisions of this MOU or as to matters not provided therein, parties to this MOU shall consult with each other for each instance and resolve such doubts in good faith.

Dispute Resolution:

In case any dispute of any kind whatsoever arises between the parties in connection with this MOU, will be resolved by mutual discussion.


Any and all disputes arising between the parties hereto in respect of, in connection with or arising from this agreement either during its subsistence or upon termination, shall be referred to arbitration of a sole arbitrator under the provisions of the Arbitration and Conciliation Act, 1996 or any other statutory modification or enactment thereof for the time being in force. The Arbitrator shall be appointed by the “**SGRR University**” whose decision shall be conclusive and binding on the parties of this agreement and the arbitration proceedings shall be held in Dehradun.

This MOU is executed in two counterparts each of which shall be deemed original but shall together constitute one document only.


