MEMORANDUM OF UNDERSTANDING (MOU)

This Memorandum of Understanding (MoU) is made on 27.09.2022 between **Shri Guru Ram Rai School of Education** (Constituent School of Shri Guru Ram Rai University), Dehradun, Uttarakhand. (**hereafter, called the 'First Party'**)

and

Manager, Shri Guru Ram Rai Education Mission, Jhanda Mohalla, Dehradun (**hereafter, called the 'Second Party'**).

The **First Party**, and The **Second Party** have agreed to the following terms and conditions of the agreement:

1. The aim of the agreement is to enhance the skills of pupil-teachers by organizing Internship Programme as well as providing effective teaching-learning conditions to the students of the School of Education from Academic Session 2022-2023 for five in the various senior secondary schools being run under the ambit of SGRR Education Mission.
2. The provisions ought to be provided by the "First Party" are given as under:-
 - A. Engage pupil-teachers according to the requirement of respective schools.
 - B. Ensure that pupil-teachers abide by rules and regulations of the school.
 - C. Overall cooperation.
3. The provisions ought to be provided by the "Second Party" (Principal of various senior secondary schools being run under the ambit of SGRR Education Mission) are given as under:-
 - A. Administrative support as organizers.
 - B. Detailed Monitoring/Report of Practicing Pupil-teachers.
 - C. Signing of the Lesson Plans.
 - D. Allotment of classes to pupil-teachers.
 - E. Certificate of Completion of Internship assurance.
 - F. Overall Cooperation.
4. Both the parties have agreed that they will extend every form of co-operation to each other.
5. The agreement shall initially commence from 1st November, 2022 onwards.
6. However, the agreement can be extended to organize more such types of programmes in future. Both the parties will be responsible for organizing and managing the program as per the provisions mentioned above.






8. The agreement shall be made in two identical copies. All the versions are equally valid. Both of the parties of the agreement shall receive one copy of the agreement.
