
WHEREAS:

CLAUSE 2

- 3.1 This Agreement will be valid until it is expressly terminated by either Party on mutually agreed terms, during which period, the Second Part.

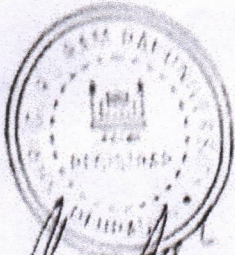
CLAUSE 4
