Welcome Address:

The meeting began with formal address by Dr.U.S.Rawat, Hon'ble Vice Chancellor & Chairmen of the Finance Committee. He welcomed all the members for their participation in the sixth Finance Committee and presented the highlights of progress of the last one year since the last meeting that was held on 17.01.2022.

Thereafter, Hon'ble Vice Chancellor invited Member Secretary to conduct the proceedings of the meeting. Initiating the business of the day, the Chief Finance Officer started the proceedings.

Agenda -1: Confirmation of minutes of 5th Meeting of Finance Committee held on 17.01.2022.

The Minutes of the meeting of Fifth Finance Committee of SGRR University held on 17.01.2022 were placed before the house for confirmation.

Member Secretary, Ashok Swami, Chief Finance Officer, SGRRIMHS presented the summary of proceedings of the Fifth Finance Committee of SGRR University. The members reviewed the minutes thoroughly and expressed satisfaction and accorded confirmation.

Resolution: The Minutes of 5th Meeting of Finance Committee held on 17.01.2022. were unanimously approved by the house. It was also unanimously resolved to send the agenda items along with annexure well in advance to all the members.

The Action Taken Report was subjected to scrutiny before the house. Budget preparation of SGRR University is still under process. House taken very seriously note on this issue and asked to prepare the budget on time for which the house decided that all the schools have to give estimated data by 15.3.23 to the CFO. Thereafter the CFO will have to present the budget of SGRR University in the month of April 2023.

If any student is not pay the fee of the new semester then he will not eligible to attend the classes, the concerned Dean/HoD/Coordinator will have to strictly follow that such students should not sit in the class.
